## Fluidigm Announces Inducement Grants Under Nasdaq Listing Rule 5635(c)(4)

SOUTH SAN FRANCISCO, Calif., Aug. 06, 2018 (GLOBE NEWSWIRE) -- Fluidigm Corporation (NASDAQ:FLDM) today announced that the Compensation Committee of its Board of Directors, which is comprised entirely of independent directors, granted equity awards effective as of July 31, 2018, under Fluidigm's 2017 Inducement Award Plan (Plan), as a material inducement to eight individuals entering into employment with Fluidigm. The equity awards were approved in accordance with Nasdaq Listing Rule 5635(c)(4).

In connection with the individuals entering into employment with Fluidigm as new employees, none of whom were previously employees or directors of Fluidigm, the individuals received awards totaling an aggregate of 53,800 restricted stock units (RSU Awards). For each employee receiving an RSU Award, and depending on each such employee's first date of employment with the Fluidigm, either 12/48<sup>th</sup> or 13/48<sup>th</sup>, as applicable, of the total number of shares of common stock underlying each RSU Award will vest on August 20, 2019, and 3/48<sup>th</sup> of the shares will vest every three months thereafter until fully vested; provided, however, that if a vesting date would otherwise fall on a day when the national stock exchange upon which the shares are listed is not open for trading, vesting will occur on the first trading day thereafter. Vesting of the RSU Awards is subject to such employee continuing to be a service provider through each such vesting date, in addition to other terms and conditions of the Plan.
